KYXX was originally known as KRCT which first opened back in 1966 under Tom Earnest and Rick Wentworth, and was located at the Williams law office building across from the Ozona Post Office. "At some point it relocated and



closed, although that is not clear. I reopened my local doors under the new call letters of KYXX on September of 2010," said Eligio.

Eligio, along with being a local Crockett County Commissioner for Precinct 4, has an Associates Degree from the Art Institute of Houston in Music Business / Video Business. "My education also includes Entrepreneurship, Sales and Marketing, Copyright Law, Recording and Sound Engineering, Video Production and Editing. I love what I do and I hope that it comes across the airwaves. I feel truly blessed with family, friends and everyone who listens in to KYXX 94.3. I thank the listeners for allowing me to be part of their morning. We are only looking to grow as a radio station."

"My wall is the best feature of the KYXX studio. It began with the 2011 Ozona Lady Lions Softball Area Champions who were the first to sign my wall, and then it took a life of it's own. I have signatures from people such as the Lipan Apache Tribe, Tumbleweed Smith, Monte Noelke from Livestock Weekly, the Pink Heals Tour Firefighters, teachers and students, local rock and tejano bands, local pastors and politicians, passer-byers-you name it! I invite anyone who comes through my door to sign their names and add to my Wall of Fame."

"KYXX has a lot to offer the business community and local residents. First, we broadcast 24/7 and our signal reach is a 30 mile radius of Ozona," said Eligio. "We are looking to reach an age demographics of 25 plus, and our format of music is Real Country-Today's Stars and Legends."

You can tune into the KYXX Morning Show with Eddy and Eligio. The show is on the air Monday through Friday from 8:40 a.m. to 10:00 a.m.. "It is an unscripted show which means we never know what we will talk about until we come on the air. We like to focus on local events, our youth and our advertisers," said Eligio.

Advertisers and non-profit organizations are invited on the air throughout the week. "Monday is Agri-Life day, we have Melissa Perner with the Ozona Stockman on Wednesdays, guests from the Ozona schools on Thursdays and other guests on Friday."

The benefits of advertising on KYXX include being a guest on the Morning Show to talk about your business or event. Commercials are heard on Ozona's KYXX and on Sonora's KHOS radio stations. You can text any last minute information or announcements during the Morning Show. You can post anything to do with your business on the KYXX Facebook page, and your business information is streamed 24/7 on the KYXX/KHOS web site.

Local businesses or organizations can also increase their visibility in the community by becoming a sponsor. KYXX offers the Ozona Lions and Lady Lions Sports Seasons, Ozona Lions Den Report, Trivia, Birthday Club, Players of the Game, and West Texas High School Scoreboard sponsorships. Chamber 2013 Plan of Action Approved

The Chamber of Commerce held its Annual Board Planning Meeting on Tuesday, January 9th, at the Visitor Center. Each year, incoming board members undergo an orientation outlining their role as a Chamber Board of Director. They are familiarized with the Chamber staff and various committees or projects. They review funding sources and the organization's Bylaws. During the annual meeting directors review the accomplishments of the Chamber for the previous year, as well as discuss the status of any on-going projects.



Board members rolled up their sleeves to discuss the 2013 Chamber Plan of
Action or Program of Work. In conjunction with the annual meeting, the board also
held its regular January board meeting. The board reviewed the 2012 year-end budget and approved the 2013 budget
for the organization.

Along with the organizations Plan of Action and budget, the board discussed everything from maintenance and technology improvements, to continued education for the staff, organizational procedures, and yearly programs and events.

In 2013, the Annual membership meeting, or banquet will be held once again at the end of March. The Business of the Year, selected by the membership, will be announced at the banquet. The Chamber will continue the Business of the Month program this year. There will be two educational luncheons held in May and July at which the Chamber will invite speakers to discuss topics of interest to the membership. The community will begin hearing about the Crockett County Interpretive Trail and the availability of memorials to place signage and benches in the trail. The Escondido Draw Recreational Area (EDRA), ATV park will open on Fridays and Saturdays in April, and the Chamber will work with the Texas Motorized Trails Coalition to market the park as a new county attraction. The Chamber will be working with area attractions of a 2013 coop advertising plan, in addition to in-town directional signage. The 3rd Bi-Annual Oil & Gas Trade Show will be held the first week in October.

Business Financials – The Aged Receivables Report

Have you ever heard the saying, "as long as someone owes you money, you will never be broke"? That sounds promising, but businesses close down every day because they are broke and unfortunately, it is because too many people owe them money.



We may ask, "How can they be broke if they are busy and have a lot of people that owe them money?" A business owner that extends credit will learn (hopefully sooner than later) that carrying credit accounts has a cost. Being owed money is not the same as having money in the bank. The business owner cannot pay his or her bills with money that is owed to them.

For this reason, a prudent business owner will run and monitor the Aged Receivables report on a regular basis (monthly at a minimum). What is an Aged Receivables report? It is the report that can be produced from nearly any bookkeeping software that tells you how many and what accounts are less than

30 days old, 31-60 days old, 61-90 days old, and over 90 days. Some reports add an over 120 days column.

Why is knowing this important? The longer that you allow accounts receivable to go uncollected, the less that account is worth to you. How can that be? The customer owed me \$200 when I made the sale, and two months later, they still owe me \$200. As I mentioned before, accounts receivable have a cost. The \$200 owed to you is \$200 you can't put



towards buying more products or paying for overhead. You also have bookkeeping costs of carrying the account, and as you try to collect on the account you spend money. This drives your profit margin down.

At some point, the cost of carrying the account will be more than the account is worth. The value of the Aged Receivables report is that you as a business owner can monitor your outstanding accounts to see how much money is overdue, by how long, and by whom. This allows you to decide how aggressive you need to be in your collection efforts.

For your overdue accounts, there are several options available to you. You, of course, can continue to monitor and attempt to collect. Another option is to hire a collections agency. A third option is called factoring and is basically selling your receivable account to an agency that specialized in factoring. The latter option is a little more involved than it sounds, but it can help keep your accounts receivable from getting too old.



The intent of this article isn't to suggest that having accounts receivable is bad. Some businesses couldn't operate if they didn't have accounts receivable. Such businesses, hopefully, are monitoring their Aged Receivables report and acting upon what they find to keep the accounts from becoming too old.
